**In this booklet there are three assignments of total 100 marks and its weightage is 30 per cent.**

**Assignment Two** has **Middle Category Questions** (MCQs). These questions require you to first analyse the topic in terms of arguments and explanations and then write the answers in a concise manner.

**Assignment Three** has **Short Category Questions** (SCQs). These questions are meant to improve your skill of recalling in brief the relevant/precise information about people, historiographical writings, events, concepts and processes.

Before you attempt the assignments, please read the instructions carefully provided in the Programme Guide. It is important that you write the answers to all the TMA questions in your own words. Your answers should be within the approximate range of the word-limit set for a particular section. Remember writing these questions will sharpen your writing skills; and you will be ready for the Term-end Examination.

As mentioned in the Programme Guide, you need to submit all the assignments within the stipulated time for being eligible to appear in the term-end examination.

- 3) **Presentation:** Once you are satisfied with your answer, you can write down the final version for submission, writing each answer neatly and underlining the points you wish to emphasize. Make sure that the answer is within the stipulated word limit.
