- 5) Define 'Rehabilitation' and bring out the principles of Rehabilitation in Health Emergencies. 10

- 7) Examine the diagnostic criteria for Post-traumatic Stress Disorder (PTSD). 10
- 8) Implementation of Mental Health Management is full of challenges and ethical dilemmas' Elucidate. 10
- 9) Discuss the importance of Water, Sanitation and Hygiene (WASH) for Disaster Management, underlining the relationship between the two. 10
- 10) Bring out the concept of Communicable Diseases and discuss the principles of Disease Control. 10
