This Assignment booklet has TMAs for the core course **BPSC 105 Introduction to Comparative Government and Politics**, which is a course on offer in the second year of the programme. This is a six credit course. You will have to do all three sections of this Tutor Marked Assignment (TMAs) whose total marks add up to 100 and carry a weightage of 30 per cent.

Assignment One has Descriptive Category Questions (DCQs). These are meant for writing essay type answers, with an introduction and a conclusion. These are intended to test your ability to describe understanding/knowledge about the topic in a systematic, to-the-point, and coherent manner.

Your answers should be within the approximate range of the word-limit set for a particular section. Remember, writing answers to assignment questions will improve your writing skills and prepare you for the term-end examination.
