Dear Student,

As explained in the Programme Guide, evaluation of a course at IGNOU comprise i) continuous evaluation through assignments, and ii) term-end examination. In the final result, assignments of a course carry 30% weightage while 70% weightage is given to term-end examination. You will have to do three assignments for a six credit course and two assignments for a four credit course. This assignment booklet has assignments for the core course **BECC-134: Principles of Macroeconomics - II**.

**Assignment I** has Descriptive Category Questions (DCQs). These are meant for writing essay type answers, with an introduction and a conclusion. These are intended to test your ability to describe your understanding/knowledge about a topic in a systematic, to-the-point and coherent manner.

**Assignment II** has Middle Category Questions (MCQs). These questions require you to first analyse the topic in terms of arguments and explanations and then write the answers in a concise manner. They are meant to test your ability to distinguish, compare and contrast, and clear understanding of the concepts and processes.

**Assignment III** has Short Category Questions (SCQs). These questions are meant to improve your skill of recall in brief the relevant/ precise information about various concepts and processes.

Before you attempt the assignments, please read carefully the instructions provided in the Programme Guide. It is important that you write the answers to all the questions in your own words. Your answers should be within the approximate range of the word-limit set for a particular section. Remember that writing answers to assignment questions will improve your writing skill and prepare you for the Term-End Examination.

As mentioned in the Programme Guide, you need to submit all the assignments within the stipulated time for being eligible to appear in the term-end examination. Completed assignments should be submitted to the **Coordinator of your Study Centre** by:

## Assignment I

Answer the following Descriptive Category Questions in about 500 words each. Each question carries 20 marks. Word limit does not apply in the case of numerical questions.

$$2 \times 20 = 40$$

- Briefly explain the implications of the IS curve. What does a point outside the IS curve mean? What do the position and slope the IS curve imply?
  - Briefly explain the implications of the LM curve. What does a point outside the LM curve mean? What do the position and slope of the LM curve imply?
- Define AS curve. What is its shape? Explain the factors that influence the AS curve.

## Assignment II

Answer the following Middle Category Questions in about 250 words each. Each question carries 10 marks. Word limit does not apply in the case of numerical questions.

$$3 \times 10 = 30$$

- Define inflation. Explain the manner in which inflation affects the following sections of society: (i) wage earners, (ii) borrowers, (iii) savers, and (iv) producers.
- Explain why the Phillips curve would be downward-sloping in the short run and vertical in the long run.
- Derive AD curve from the IS-LM model. What are the factors that influence the slope of the AD curve?

## Assignment III

Answer the following Short Category Questions in about 100 words each. Each question carries 6 marks.

$$5 \times 6 = 30$$

- Explain the concept of natural rate of unemployment.
- Distinguish between fixed and flexible exchange rate regimes.

8. Distinguish between nominal exchange rate and real exchange rate.
9. Explain the impact of supply shocks on output and price levels.
10. In the IS-LM model, explain why the economy always moves towards the equilibrium point.
