- 3) **Presentation:** Once you are satisfied with your answer, you can write down the final version for submission. **It is mandatory to write all assignments neatly in your own handwriting and Write your Name, Course Code, Enrollment No. and Batch of admission on all the assignments in bold letters.**

If you so desire, you may underline the points you wish to emphasize. Make sure that the answer is within the stipulated word limit.
